Consider Approval of Resolution 11-2009 – Setting Refuse Rates

William T. Gentzler made a motion, seconded by Michael H. Altland, to approve an increase in refuse collection service from \$40.00 to \$45.00/quarter beginning January 2010. Motion carried.

<u>Consider Approval of Resolution 12-2009 – Establishing Wages, Salaries and</u> Compensation

James G. Decker made a motion, seconded by William T. Gentzler, to approve Resolution 12-2009, which sets the wage and salary schedule for 2010. Motion carried.

<u>Consider Approval of Resolution 13-2009 – Establishing a Miscellaneous Fee Schedule</u> for 2010

William T. Gentzler made a motion, seconded by Michael H. Altland, to approve Resolution 13-2009, which sets the miscellaneous fee schedule for 2010. Motion carried.

Consider Approval of Resolution 14-2009 – Setting Sewer Rates for 2010

William T. Gentzler made a motion, seconded by Benjamin L. Spagnola, to approve an increase in sewer service for 2010 as follows:

Residential Use: Increasing base rate from \$60.00 - \$70.00.

L. Commercial Use: Increasing base rate from \$80.00 to \$100.00.

Heavy Commercial Use: Increasing base rate from \$120.00 to \$150.00.

Industrial use: Increasing the Employee rate from \$15.50 to \$16.50. Motion carried.

Consider Approval of the 2010 Hemler Animal Control Contract

Neal J. Doyle made a motion, seconded by William T. Gentzler, to approve the Hemler Animal Control Contract for 2010. Motion carried with opposing votes from Benjamin L. Spagnola and Michael H. Altland.

Consider Approval of the 2010 Southwestern Regional Police Budget

William T. Gentzler made a motion, seconded by James G. Decker, to approve the 2010 Southwestern Regional Police Budget. Motion carried.

Consider Approval of Ordinance 3-2009 – Establish Real Estate Tax Rate

William T. Gentzler made a motion, seconded by James G. Decker, to adopt Ordinance 3-2009, which establishes the millage tax rate for 2010 at a rate of 2.84 mills. Motion carried. It was noted that there was no increase for 2010.

Consider Approval of the 2010 Budget

Michael H. Altland made a motion, seconded by Neal J. Doyle, to approve the 2010 Budget for Spring Grove Borough. Motion carried.

<u>Consider Authorization for Advertisement – Meeting Schedule</u>

Michael H. Altland made a motion, seconded by Benjamin L. Spagnola, to authorize the advertisement of the Meeting Notice Schedule for 2010. Motion carried.

<u>Consider Accepting the Resignation of Robin Price from the Spring Grove Regional Parks & Recreation Center Board</u>

William T. Gentzler made a motion, seconded by James G. Decker, to accept the resignation of Robin Price from the Spring Grove Regional Parks and Recreational Center Board with regret due to the overwhelming workload of her job. Motion carried.

At this time President Legore presented a Resolution of Respect to James G. Decker for his 19 years of service on Borough Council, along with his many years of service as a coach of the Spring Grove Youth Baseball, and his service with the Trinity Roth UCC Church.
