E-Bill Respone

Manager Shaffer informed Council that the response for electronic billing of the sewer and refuse bills has been positive but not enough to consider implementing at this time.

Street Light-Final Phase Spring Forge Development

Manager Shaffer advised Council that Met-Ed informed him that the final phase of street lights in Spring Forge Development cannot be divided. The borough does not need to assume any responsibility for the street lights until at least 80% of the development is completed. Due to the economy, Council felt that they could not justify the estimated \$400-500 monthly expense for just one home.

Spring Grove Community Park

Manager Shaffer informed Council that the bids for the Spring Grove Community Park will be opened on February 25, 2009. A pre bid meeting will be held on February 9th.

2009 Sewer Main Replacement Project

Manager Shaffer reported to Council that he has received a letter from DEP that all of the approvals have been granted from the York County Conservation District and DEP. He expects to ask for authorization to advertise at the March Council meeting, with a start up time in late summer.

2009 Street Improvement Projects

Engineer Knouse informed Council that C.S. Davidson, Inc. has completed their preliminary planning work for the 2009 Street Improvement projects. He recommended that Council consider Cherry and Constitution Avenues and felt that the cost for these streets would be able to be within the borough's budget. He also asked that Brad and Manager Shaffer inform them of any problem areas that may develop due to the winter weather.
