## 2009 Street Improvement Projects

## Consider Rejection of the Low Bid from Womex, Inc.

Engineer Mike Knouse reported to Council that the bids for the 2009 Street Improvements Project were publicly opened on April 28<sup>th</sup>, 2009. The low bid came in by Womex, Inc. in the amount of \$33,711.00. However, he advised Council that Womex, Inc. failed to submit the signed addendum that was included with the specs for the project. Based on that, he recommended that Council reject Womex, Inc.'s bid. William T. Gentzler made a motion, seconded by Michael H. Altland, to reject the low bid by Womex, Inc. Motion carried.

## Consider Approval of the Low Bid from Fitz and Smith

William T. Gentzler made a motion, seconded by James G. Decker, to approve the next low bid by Fitz and Smith, Inc. in the amount of \$34,369.00 for the 2009 Street Improvements. Motion carried.

## Floodplain Management Ordinance Update

Engineer Knouse reported to Council that he has received correspondence from FEMA stating that the Borough's Flood Plain Management Ordinance needs to be brought up to date with the latest requirements of the National Flood Insurance Program (NFIP). Council was informed that should the Borough not comply, the Borough would be unable to obtain flood insurance, some types of disaster assistance, as well as state and federal grants and loans.

#### Consider Authorization for ARRO- GIS Mapping

William T. Gentzler made a motion, seconded by Michael H. Altland, authorizing ARRO to create a GIS (Geographic Information System) for the Borough's Sanitary Sewer System at a contract price of \$36,700, which includes the Base Scope, Option 2, Option 4 and Option 5. Motion carried.
